

2. Interview will be conducted only for those candidates who are Short Listed after scrutinizing the received applications. Interview will be held via Hybrid Mode (Online/Offline).
3. The interview is tentatively scheduled for 21.07.2026 at CSB-CTRTI, Piska-Nagri, Ranchi (Jharkhand) 835303 (only for the shortlisted candidates). Recent passport size photograph and photocopies of relevant certificates and other testimonials in support of age, qualification, experience etc. should be sent along with the application as a single PDF file by email. (The shortlisted candidates must bring one set of photocopy of all the relevant document besides original certificates which will be verified during the interview).
4. The applicants who attend online, in case of their successful selection, their appointment will be subject to verification of the original documents at the time of reporting.
5. The applicant will be held responsible for the authenticity of information submitted / documents and photograph. It is the responsibility of the candidate to assess his / her own eligibility for the post(s) for which he / she is appearing in accordance with this advertisement. If it is detected at any time in future, during the process of selection or even after the appointment that the candidate was not eligible as per the prescribed eligibility criteria in this advertisement, which could not be detected at the time of selection for whatsoever reason, his/her candidature/appointment shall be liable to be cancelled/terminated immediately.

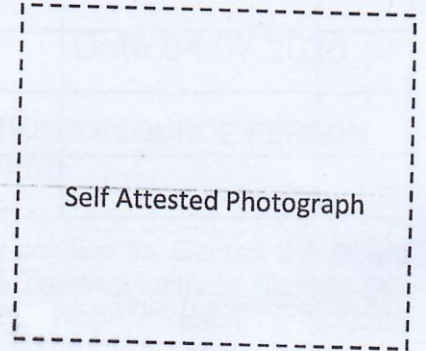
